Litchfield County Affordable Homeownership Program

Program Overview & Pre-application Form

Thank you for your interest in purchasing an affordable home. The Litchfield County Affordable Homeownership Program is currently building 9 new homes in Salisbury (4 homes), Cornwall (3 homes), Norfolk (1 home) and Washington (1 home) in partnership with the local housing non-profits in those towns. Below is information on the Program and the Pre-Application form. Please fill in and submit the Pre-Application form if you are interested.

Program Overview

WHO IS ELIGIBLE

To qualify, your total gross annual household income must be at or below 100% of the Litchfield County Area Median Income (AMI) For your reference, the current income limits by households size are listed below. Your ssets will also be assessed to make sure your household is eligible (total sum of all financial accounts should not be greater than \$100,000).

Applicants must be first-time homebuyers - that is defined as an individual or household of which no household member has had an ownership interest in a principal residence at any time during the past three (3) years. Please also note that all selected purchasers must occupy the affordable home as their primary residence. As these are all 3-bedroom homes, there will be a strong preference for households with three or more people. Finally, we are requiring that applicants pre-qualify for a mortgage of at least \$250,000. This pre-qualification does not have to be from the bank that you ultimately intend to borrow from, but you must show that you are able to qualify for a mortgage, based on your current household income.

We are also strongly encouraging applicants to conduct the Housing Development Fund (HDF) Pre-purchase Homebuyer Counseling. This is a FREE service in which a homeownership advisor will assess your ability to acquire a mortgage and review your elgibility for loan and downpaymernt assistance in Connecticut. <u>Click here to visit the HDF webpage</u> and learn more.

HOMES FOR SALE

These are three-bedroom Cape-style homes that are being built now. They will be sold to income eligible buyers for between \$250,000 and \$280,000 including a forgivable downpayment assistance loan of

approximately \$25,000. This is a shared equity homeownership model where the homebuyers will purchase the house that sits on land owned by the local housing nonprofit. The homeowners lease the land from the local housing non-profit in a long-term lease. The homeowners agree in the lease that when they want to sell the home they will sell it at a price to keep it affordable to households at or below 100% of the area median income. For more details, ask us for a sample ground lease.

WHEN WILL HOMES BE READY FOR PURCHASE?

The first homes will be ready for purchase in Salisbury in May 2025. The next homes will be ready in Cornwall this summer and in Washington and Norfolk this Fall/Winter. These timelines are subject to change, please contact us for the latest news on specific homes in specific towns.

WHAT IS THE APPLICATION PROCESS?

- Submit the Pre-Application form by emailing it to LindsayL@thehousingcollective.org or mailing it to the local housing organization in the town of interest.
- 2) If there are more than 3 eligible pre-applications per available home, all eligible pre-applications will be entered into a lottery. Three pre-applications per home will be selected to submit a full application.
- 3) If you are eligible and selected via lottery, you will be asked to submit a full application package including income and asset documentation like your tax returns, paycheck stubs, and bank statements to ensure that your household is income eligible for this homeownership opportunity.
- 4) If there are multiple income eligible households interested in a specific home, they will be entered into a lottery.
